In addition, you can use your online account to submit your annual affidavit and renew expired certifications.

Your firm will also be listed in the New York City Directory of Certified Businesses ([www.nyc.gov/buycertified](http://www.nyc.gov/buycertified)) so we can connect you to government buyers and prime contractors who may be looking for certified companies such as yours.
